OFFICIAL MAIL-IN REBATE TERMS AND CONDITIONS (CONTINUED)

1. Limit 2 Visa Prepaid Card redemptions per household, customer or email address. Purchase must be four identical qualifying tires for a single vehicle. The required invoice for a second redemption per household, customer or email address must show purchase of an additional set of 4 qualifying tires for a different vehicle than the one referenced in the first redemption.
