CUSTOMS POWER OF ATTORNEY (Instructions page 1 of 3)

THE U.S. CUSTOMS SERVICE HAS ISSUED AN AMENDMENT OF THE REGULATIONS TO PROVIDE AN ALTERNATIVE PROCEDURE FOR AN IMPORTER OF RECORD TO PAY DUTIES ON THE IMPORTED MERCHANDISE THROUGH A LICENSED CUSTOMSHOUSE BROKER. PREVIOUS RULES PROVIDED FOR THE PAYMENT OF DUTIES TO CUSTOMS BY A BROKER ON BEHALF OF THE IMPORTER. UNDER THE ALTERNATIVE PROCEDURE, THE IMPORTER MAY ELECT TO SUBMIT TO THE BROKER A SEPARATE CHECK OR BANK DRAFT FOR THE DUTIES PAYABLE TO THE "U.S. CUSTOMS SERVICE." THE BROKER THEN DELIVERS THE IMPORTER'S CHECK OR BANK DRAFT TO CUSTOMS. THE NEW RULE ALSO REQUIRES BROKERS TO PROVIDE WRITTEN NOTIFICATION TO THEIR CLIENTS ADVISING THAT IF THE CLIENT IS AN IMPORTER OF RECORD, PAYMENT TO THE BROKER WILL NOT RELIEVE THE CLIENT OF LIABILITY FOR CUSTOMS CHARGES IN THE EVENT THAT THE CHARGES ARE NOT PAID BY THE BROKER. BROKERS WILL BE REQUIRED TO PROVIDE THIS NOTIFICATIONS TO ALL ACTIVE CLIENTS ANNUALLY DURING THE MONTH OF FEBRUARY. ADDITIONALLY, BROKERS WILL BE REQUIRED TO PROVIDE SUCH INFORMATION ON A POWER OF ATTORNEY EXECUTED ON OR AFTER THE EFFECTIVE DATE OF THE NEW RULE. THESE AMENDMENTS ARE REFEECTIVE AS OF SEPT 27, 1982
