RULES OF THE MARINA

- 1. No swimming or <u>fishing</u> is allowed on the docks. (Hooks in canvas & in people!) <u>NO EXCEPTIONS!</u>
- 2. Shoes must be worn at all times everywhere on our property; this is for your protection!
- 3. The <u>marina waters act as a "NO-WAKE-ZONE"</u>; this includes the area surrounding the gas dock; any reckless boaters will be asked to leave the marina if multiple offenses are found.
- 4. NO SELF-FUELING (jerry jugs) allowed on the docks. This is a fire hazard, and is dangerous for everyone. It is against the Fire Marshall's regulation, is a serious offense, and may be subject to a fine from the Department of Energy & Environmental Protection. If you are caught self-fueling on our docks, you willbe asked to leave the Marina permanently & WITHOUT REFUND for your dockage!
- 5. All boats must be covered. If your boat must be pumped because it is taking on a significant amount ofwater, you will be charged!
- 6. All boats must <u>have appropriate dock line to hold the weight of your boat</u>. If it is not, <u>we will provide astronger rope at your expense</u>
- 7. On weekends, customer may only have <u>ONE</u> car per customer; family members & guests can park at our storage facility and carpool back to the Marina. Please call for any special situations, we will try towork with you the best we can.
- 8. All customers are required to <u>display a current Gerard's Marina Parking Sticker</u>; this can be obtained once proof of insurance is given and all balances are cleared. <u>Please be polite/patient with our staff who may insist on your adherence to this rule</u>, this if fort YOUR protection and enhances our security and safety around the facility.; your compliance is greatly appreciated.
- 9. There is absolutely **NO SWIMMING** around/ off the docks near the marina and please keep your children **OFF THE ROCK FEATURE** & off the rocks in **FRONT OF THE FACILITY; NO EXCEPTIONS**
- 10. Dogs are welcome but they <u>MUST</u> be on a leash (from the moment you exit your vehicle), and their <u>poop</u> must be scooped. <u>NO EXCEPTIONS</u> (Ownership & Staff may have personal dogs on property, leashing your dog can save us all headaches with the potential of "arguing" dogs)
- 11. The outside bathroom is exclusive to Marina customers who dock here
- 12. <u>Please do not give this code to anyone.</u> Parents, please take the time to walk your children and guests to the bathroom. Be sure when you are finished that the door is <u>closed</u> tightly behind you
- 13. Children should not be left unattended. Children under the age of 18 are not permitted to be here alonein the evenings (Dusk to Dawn)
- 14. All dock edging must be removed before your boat is pulled out of the water in the fall, otherwise you forfeit your property.
- 15. The access ramp is available upon request only; you must contact the office at least 3-days prior before your intended use date.
- 16. Jet skis are not permitted to be brought in and out of the water on a regular basis (No Exceptions)
- 17. NEVER BLOCK RAMP ACCESS WITH ANY VEHICLE (Including golf carts & motor cycles); this is extremely important in case of an emergency; Parking Passes must be displayed at all times in order to avoid tow away at your coast.
- 18. No outside service work is allowed; our insurance does not cover this. (No Exceptions)

- 19. We are not responsible for any damage or theft of property on your vehicles or vessel(s) docked at themarina **You must have your own** insurance
- 20. In the event of a <u>theft, damage</u> or <u>altercation</u> of any kind, it is the customers sole responsibility to <u>1) report it to the office</u>, <u>2) request video footage within 6 days of incident</u> and <u>3) not to engage physically or verbally with any persons on our property (this especially includes staff).</u> Speak to management (M-F) or the office admin staff on Saturdays & Sundays with <u>ALL</u> issues.
- 21. Gerard's Inc. is now a "No-Smoking" facility; Please observe all signs both in & outside of the building.
- 22. It is understood that the **member** is responsible for any and all damages caused to the Gerard's Marinaproperties including Docks, Vessels /PWCs, Restrooms, Gas or Rental Equipment or any other Marinaproperty.
- 23. Gerard's Marina is a diverse family establishment and reserves the right to hold members accountable for their behavior and may be asked to leave without refund if multiple offenses are logged. (i.e., loud and offensive language, violent actions, consistent confrontations with staff or customers, espousing violent rhetoric or slurs of any kind will not be tolerated)
- 24. <u>COVID-19 Policies:</u> Gerard's Marina and its staff believe in individual freedom and the rights for all citizens to participate in our democratic way of life, in turn, we will NOT enforce any draconian policies that limit your ability to enjoy or participate in our services. However! If you or your family members are immune compromised and request additional protection or need extra service, please do not hesitate to ask!

These rules help ensure new customers understand our policies and community and serve as a reminder for returning customers. We hope to offer a happy and safe environment for all family and friends!
