### Assumption of Risk

Knowing and understanding these risks, I voluntarily assume all risks associated with my participation in any Jet-A-Marina Tournament Series event, whether caused by negligence or fault of the Event Organizer, it's officers, directors, volunteers, or sponsors (collectively, the "Releasees").

### Waiver and Release of Liability
