## Stevens Marine, Inc. Storage Agreement Page 2 Terms

Stevens Marine, Inc. will provide storage and services as indicated on the reverse side to the boat owner and both parties agree as follows:

- 1) The standard storage fees are payable as half down upon receipt of storage agreement **(PRIOR TO HAUL OUT)** and the balance due upon completion and final billing or no later than December 1, 2025. Any storage invoices not paid by December 1, 2025 will forfeit any discount applied and incur interest charges at the rate of 18% annual. No spring service work will be scheduled until all storage bills are paid in full. All spring service invoices must be paid prior to launch.
- 2) Boat Owner agrees to carry adequate insurance to cover any injury or damage to property from use or access of boat while stored at this facility and provide evidence of coverage.  
**Certificate of proof of insurance is required with storage contract.**
- 3) Boat owner agrees at all times to indemnify, defend and hold Stevens Marine, Inc. harmless against all claims, actions, costs, damages, loss or expenses incurred by boat owner resulting from vandalism or the negligent actions of any individual or business other than Stevens Marine, Inc. who is utilizing any of the Stevens Marine, Inc. property.
- 4) Stevens Marine, Inc. will not permit outside vendors to conduct business at our facility unless notified and approved by us and we are in receipt of vendor's certificate of liability insurance naming Stevens Marine, Inc. as certificate holder. No vendors will be permitted to conduct business on Stevens Marine, Inc. property if it is a service we provide.
- 5) Stevens Marine, Inc. will not be liable and owner releases Stevens Marine, Inc. from any liability for damages to, destruction of or theft of the boat, its equipment and contents. Stevens Marine, Inc. is not liable for damage occurring due to adverse weather.  
Owner  
agrees to provide proof of sufficient insurance coverage for the stored boat, its equipment and contents.
- 6) Absolutely no boats are to be left plugged in if owner is not present. No space heaters are to be used unless the owner is present and heaters are to be unplugged upon departure. No exceptions!
- 7) Price of shrinkwrap includes labor and materials for framing and shrinkwrap installation. The owner is responsible for removing shrinkwrap. An additional charge of \$125.00 will be incurred for Stevens Marine to remove shrinkwrap in the spring.
