**FOR WINTER STORAGE CUSTOMERS, Storage needs to be paid in full at the time you sign this agreement.** Your storage space will not be reserved until this agreement is signed and storage is paid in full. This agreement is for a period from first day storage begins to last day storage ends – not to extend beyond May 31<sup>st</sup>. If unit remains on our premises after that date, there will be a \$5 per day charge until unit is removed from CEDAR LAKE SALES & SERVICE premises. (No key will be issued for winter storage customers.) **Please note that we require three weeks notification in advance of the week your boat is to be ready for spring delivery or pick-up.** Thank You!

While your boat is in storage at Cedar Lake Sales & Service, you must make sure that your insurance remains in effect through the storage season. CEDAR LAKE SALES & SERVICE IS NOT RESPONSIBLE FOR ANY DAMAGE TO YOUR BOAT, MOTOR, TRAILER OR ACCESSORIES FOR ANY REASON. We are NOT RESPONSIBLE for personal items left in your boat, therefore we recommend that they be removed by the boat owner prior to bringing it in for storage. Cedar Lake Sales takes necessary precautions to protect our storage facilities as well as deter mice and any other critters from entering our buildings. **We highly recommend that customers take precautions to thoroughly clean and remove any potential animal attractants from your boat.** Cedar Lake Sales will not be held responsible for ANY DAMAGE FOR ANY REASON.

**FOR MONTH TO MONTH OR SUMMER STORAGE CUSTOMERS, the first month of storage is prepaid, then paid upon receipt of invoice or customer will be charged interest in the amount of 1.5% per month (18% annual rate) and a \$25 late fee for past due accounts. No unit will be removed from CEDAR LAKE SALES & SERVICE premises until all charges are fully paid. Storage is not considered ended until the key is returned to Cedar Lake Sales.**

By signing this agreement you, the customer, are bound by the terms and conditions contained herein for this and any subsequent year in which you, the customer, presents boat, motor, trailer to CEDAR LAKE SALES & SERVICE for storage.
