

**OFFICIAL RULES FOR
THE TIRE PROS® OFF ROAD IN ARIZONA SWEEPSTAKES**

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE OR INCREASE YOUR CHANCES OF WINNING. ODDS OF WINNING WILL DEPEND ON THE TOTAL NUMBER OF ELIGIBLE ENTRIES RECEIVED. VOID WHERE PROHIBITED BY LAW.

1. Sweepstakes Description

The Tire Pros® Off Road in Arizona Sweepstakes (“Sweepstakes”) is sponsored by Tire Pros FranCorp, 12200 Herbert Wayne Court, Suite 150, Huntersville, NC 28078 (“Sponsor”). The Sweepstakes entry period begins at 11:59 am EST on Saturday, August 5, 2017 and ends at 11:59 pm EST on Saturday, September 2, 2017 (the “Entry Period”). One (1) grand prize described in Section 5 below will be awarded based on a random drawing of eligible entries received during the Entry Period. This Sweepstakes is void where prohibited and subject to all local, state, and federal laws and regulations.

2. Eligibility

The Sweepstakes is open to legal residents of the forty-eight (48) continental United States (excluding Alaska and Hawaii) and the District of Columbia, age eighteen (18) or older (residents of Nebraska and Alabama must be at least nineteen (19) years old to enter). Employees of Sponsor, or any Tire Pros location, American Tire Distributors and each of their respective parent and affiliated entities, franchisees and dealerships, and each of their respective advertising and marketing agencies and any party involved with the administration of the Sweepstakes (collectively all of these entities to be referred to as the “Sweepstakes Entities”) and members of such employees’ respective immediate families (parent, spouse, child, sibling, grandparent and grandchild) regardless of whether they reside in the same household, and members of the same household of such employees, are not eligible to enter. Void where prohibited.

3. How to Enter

You can only enter online at www.tireprossweepstakes.com by completing the entry form with your name, date of birth, email address, phone number and mailing address. Standard data access charges may apply to entry by mobile phone; check with your wireless carrier. Limit one (1) entry per person. Sponsor’s computer for receiving entries shall be the official time clock for this Sweepstakes. Each entry must be manually key stroked and manually entered by the individual entrant; automated and/or repetitive electronic submission of entries (including but not limited to entries made using any script, macro, bot or sweepstakes service) will be disqualified. If you are suspected of attempting to register or enter in excess of the specified registration/entry limits, by any means, including but not limited to establishing multiple e-mail accounts, or using any automated means to enter, you may be disqualified in Sponsor’s sole discretion.

In the event of a dispute over the identity of a potential grand prize winner, the entry will be declared made by the authorized account holder of the email address submitted at the time of entry, and any potential winner may be required to provide evidence sufficient to show that he/she is the authorized account holder of the email address. It is the sole responsibility of the entrant to notify Sponsor in writing if the entrant changes his or her e-mail or postal address or phone number.

Sponsor is not responsible for lost, late, incomplete, damaged, stolen, invalid, unintelligible or misdirected entries. Sponsor is not responsible (a) if online service or equipment is interrupted including without limitation (1) interruptions to any network, server, Internet, Web site, telephone, satellite, computer or other connections, (2) failures of any telephone, satellite, hardware, software or other equipment, (3) garbled, misdirected or jumbled transmissions, or traffic congestion, or (4) other errors of any kind, whether human, technical, mechanical or electric, or (b) for the incorrect or inaccurate capture of entry or other information or the failure to capture any such information.

4. Winner Selection and Notification

On or about September 8, 2017, a random drawing will be conducted by Sponsor from among all eligible entries received by Sponsor to select the potential grand prize winner. The odds of winning depend on the number of eligible entries received during the Entry Period. The potential grand prize winner will be notified by phone, e-mail or regular mail, in Sponsor's sole discretion. If a potential winner does not respond to the prize notification or cannot be reached within forty-eight (48) hours of the initial communication, any prize notification is returned as undeliverable, or any Documents specified in Section 7 below are not returned within forty-eight (48) hours of receipt by the potential winner, the potential winner may be disqualified in the sole discretion of Sponsor and an alternate potential winner randomly selected from the remaining eligible entries. A potential winner will be deemed the winner upon meeting all of the conditions and requirements set forth in these Official Rules (the "Winner").

5. Prize

One (1) grand prize ("Grand Prize") will be awarded. The Grand Prize Winner will receive two (2) VIP tickets to attend the 2017 Lucas Oil Off Road Racing Series Round 13 and Challenge Cup races scheduled to take place October 21-22, 2017 at the Wild Horse Motorsports Park in Chandler, AZ. The Winner will also receive two (2) hospitality passes to the BMI Racing hospitality/pit area for both days. Prior to the race, the Winner and guest will have the opportunity to meet professional driver and Tire Pros advocate Sarah Burgess.

The Grand Prize also includes coach airfare travel from the major airport nearest the Winner's residence to the airport. If the travel is approximately two hundred (200) miles or less, Sponsor may substitute ground transportation for air travel. If the Winner chooses to opt out of Sponsor's ground transportation or if the Winner chooses to decline roundtrip airfare, Sponsor at its discretion will provide the Winner a \$150.00 Visa® prepaid gift card to be used for gas and other vehicle expenses, regardless of mileage. The Grand Prize also includes two night's lodging for one room (double occupancy) at a hotel in or near the city of the championship location, chosen by Sponsor. Ground transportation is only for travel to and from the airport to the designated hotel and to and from the designated hotel to the track where the race is taking place. In addition, Sponsor will provide the Winner with a \$500.00 Visa® prepaid gift card to be used at the Winner's discretion. The total approximate retail value of the Grand Prize is \$4,600.00.

The Grand Prize Winner is not entitled to any difference between the ARV and the actual value of the prize (which could vary based on the departure destination of the trip). All expenses and incidental travel costs not expressly stated in the package description above, including but not limited to, ground transportation to the departure airport, parking, meals, incidentals, gratuities, passenger tariffs or duties, airline fees, surcharges, airport fees, service charges or facility charges, personal charges at lodging, security fees, taxes or other expenses are the responsibility solely of the winner.

The travel companion/guest must be at least eighteen (18) years of age or older as of the date of departure. Travel restrictions, conditions and limitations may apply. Sponsor will not replace any lost, mutilated, or stolen tickets, travel vouchers, gift cards or certificates

Sponsor makes no representation or warranty regarding the Grand Prize, and expressly disclaims any and all express or implied warranties, including without limitation the implied warranties of merchantability and fitness for a particular purpose. All Grand Prize details, including, without limitation, the exact nature and duration of the meet and greet shall be determined in the sole and absolute discretion of Sponsor and subject to availability. Ticket locations at the race shall be determined in the sole and absolute discretion of Sponsor.

No assignment or transfer of the prize will be permitted, except at Sponsor's sole discretion. Sponsor reserves the right to substitute a prize with one of comparable or greater value if an advertised prize is unavailable for any reason including, race cancellation, acts of God, force majeure and other causes beyond the Sponsor's control. The Grand Prize cannot be redeemed for cash. The Winner is solely responsible for all federal, state and local taxes associated with the receipt of the prize. The Winner will be issued a Form 1099 in the amount of the prize.

Except as noted above, Sponsor does not guarantee any particular location for the tickets. Sponsor is not responsible if any of the races are delayed, postponed or cancelled for any reason, in which event that portion of prize is forfeited in its entirety and no substitution will be provided except as in Sponsor's sole discretion. Winner and his/her guest agree to comply with all Track rules and regulations in connection with the Grand Prize. Sponsor reserves the right to remove or to deny entry to Winner and/or his/her guest who engage in a non-sportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person at the Race.

6. Acceptance of Official Rules

As a condition of entry, entrants fully and unconditionally agree to these Official Rules and to Sponsor's decisions, which are final and binding in all respects.

7. Prize Documents and Releases

- (a) The Grand Prize Winner must sign an affidavit of eligibility and a liability/publicity release (unless prohibited) as well as any required W-9 and other tax-related forms (collectively "Documents") and return the Documents within forty-eight (48) hours of issuance by Sponsor. In addition, the Winner's travel companion/guest must execute liability/publicity releases prior to issuance of travel documents.

- (b) By participating in this Sweepstakes or receiving the Prize, entrants agree to release and to indemnify and hold harmless the Sweepstakes Entities and each of their officers, directors, employees and agents from any liability, injury, death, loss or damages to entrant or any person or entity, including without limitation, damage to personal or real property, caused in whole or in part, directly or indirectly, by participation in this Sweepstakes (or related activities) or the acceptance, possession or use/misuse of the grand prize, or any grand prize-related travel or activity.

Sponsor reserves the right to cancel or modify the Sweepstakes (or any portion thereof) if fraud, misconduct or technical failures destroy the integrity of the Sweepstakes or if a computer virus, bug, or other technical problem corrupts the administration, security, or proper administration of the Sweepstakes, as determined by Sponsor, in its sole discretion. If the Sweepstakes is so cancelled, Sponsor reserves to select the winner by a random drawing from among all eligible entries received prior to the time of termination. Inclusion in such drawing shall be each participant's sole and exclusive remedy under such circumstances. If due to a printing, production or other error, more prizes are claimed than intended to be awarded as described in Section 5, the intended prize will be awarded in a random drawing from among all verified and validated prize claims received for that prize level. In no event will more than the stated number of prizes be awarded. Sponsor reserves the right in its sole discretion to prohibit the participation of an individual if fraud or tampering is suspected, or if the individual fails to comply with any requirement of participation as stated herein or with any provision in these Official Rules, or acts in unsportsmanlike or disruptive manner. These Official Rules cannot be modified or amended in any way except in a written document issued by a duly authorized representative of Sponsor. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and shall be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

CAUTION: ANY ATTEMPT BY AN ENTRANT OR ANY OTHER INDIVIDUAL TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES MAY BE A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH PERSON TO THE FULLEST EXTENT PERMITTED BY LAW.

9. Disputes/Choice of Law

Except where prohibited, each entrant (a) agrees that: (1) any and all disputes, claims and causes of action arising out of or connected with this Sweepstakes or any prize awarded shall be resolved individually, without resort to any form of class action, and exclusively by state or federal courts situated in the state of North Carolina, (2) any and all claims, judgments and awards shall be limited to actual out-of-pocket costs incurred, but in no event attorneys' fees, and (3) no punitive, incidental, special, consequential or other damages, including without limitation, lost profits, may be awarded (collectively, "Special Damages"), and (b) hereby waives all rights to claim Special Damages and all rights to have such damages multiplied or increased. North Carolina law, without reference to choice of law rules, governs the Sweepstakes and all aspects related thereto.

10. Privacy

Personally identifiable information that is submitted by entrants as part of this Sweepstakes will be used to administer the Sweepstakes, select the Grand Prize Winner and fulfill the prize, and for other purposes as set forth in Sponsor's privacy policy accessible at <http://www.tirepros.com/privacy-policy> and may be shared with third parties for purposes of Sweepstakes administration and for other purposes set forth that privacy policy.
