McCLAIN TRAILERS PROPER ADDRESS CONCERNING WARRANTY MATTERS IS AS FOLLOWS:

McCLAIN WARRANTIES ARE LIMITED TO THE ORIGINAL RETAIL PURCHASER (hereinafter "PURCHASER") ONLY, AND ARE NOT TRANSFERABLE TO ANY SUBSEQUENT OWNERS OF THE TRAILER. McCLAIN WARRANTS ONLY THE PRODUCT IT MANUFACTURES AND DOES NOT WARRANTY ANY OTHER PRODUCTS THAT ARE COMPATIBLE FOR USE WITH THE TRAILER, NOR FOR ANY ADVERSE EFFECTS SUCH OTHER PRODUCTS MAY HAVE ON THE TRAILER.

McCLAIN'S WARRANTY IS FOR A PERIOD OF TWELVE (12) MONTHS FROM THE DATE OF SALE TO THE PURCHASER.

DURING THE WARRANTY PERIOD, McCLAIN WILL REPAIR OR REPLACE AT IT'S OPTION, FREE OF CHARGE, INCLUDING ANY LIMITED RELATED LABOR CHARGES FOR PARTS THAT ARE FOUND TO BE DEFECTIVE BECAUSE OF DEFECT IN MATERIAL OR WORKMANSHIP, WHEN THE REPAIR WORK IS DONE BY AN AUTHORIZED DEALER, WITHIN A REASONABLE AMOUNT OF TIME AFTER THE TRAILER IS DELIVERED TO SUCH AUTHORIZED DEALER.

IT IS THE RESPONSIBILITY OF THE PURCHASER TO COMPLETE THE WARRANTY REGISTRATION FORM AT THE TIME OF PURCHASE AND RETURN IT TO McCLAIN. IN ADDITION, THE PURCHASER MUST RETURN THE TRAILER TO AN AUTHORIZED DEALER FOR ANY WARRANTY WORK. NO TRANSPORTATION CHARGE WILL BE PAID BY McCLAIN.

THIS WARRANTY DOES NOT COVER BEARINGS OR TAIL AND CLEARANCE LIGHTS. IT IS THE OWNER'S OBLIGATION TO PROPERLY CARE FOR WHEEL BEARINGS AND TAIL AND CLEARANCE LIGHTS. THIS WARRANTY DOES NOT COVER PAINT OR CHROME.

THE FOLLOWING VOIDS THIS WARRANTY: (1) OVERLOADING BEYOND THE STATED CAPACITIES. (2) REPAIRS BY AN UNAUTHORIZED DEALER. (3) ANY TRAILER THAT HAS BEEN SUBJECTED TO ALTERATIONS, ACCIDENT AND/OR NEGLIGENT OPERATION. (4) EQUILIZER TYPE HITCHES USED IN CONJUNCTION WITH HYDRAULIC SURGE BRAKES VOIDS ALL BRAKE WARRANTY, (5) FAILURE TO LIST SERIAL NUMBER.

THIS WARRANTY IS INTENDED TO COMPLY WITH THE "LIMITED WARRANTY" PROVISIONS OF THE FEDERAL "MAGNUSON-MOSS FEDERAL TRADE COMMISSION IMPROVEMENT ACT" AND ANY PROVISIONS OF THIS WARRANTY OR ACTIONS TAKEN BY McCLAIN PUDSUANT TO THIS WARRANTY SHALL BE CONSTRUED ACCORDINGLY.

## REPORTING SAFETY DEFECTS
